

## ■ Shipping Instructions: Submission of dangerous goods (DG) details

March 1<sup>st</sup>,2011

Dear Customer,

various countries require the submission of detailed cargo information prior to vessel sailing (24 hour security initiatives) and/or prior to arrival at destination to local customs and port authorities.

With the introduction of EU-AIS as of January 1<sup>st</sup>, 2011, we have identified that especially dangerous goods information require further attention in order to comply with the related customs requirements. This is not limited to EU-AIS but is also essential for other advanced manifest systems e.g. AMS (USA), ACI (Canada), MX-SAT (Mexico), and CCAM (China).

As customs manifests have to be submitted on document basis, authorities also require DG cargo details per document. Details as per dangerous goods declaration is not sufficient, as such information is based on container level.

With immediate effect, we have to request that your shipping instructions will reflect DG and non-DG cargo description separately. DG cargo descriptions must at least contain following details:

- IMO class
- UN number
- Quantity
- Weight

Please also note that the combination of DG and non-DG cargo and a mix of several UN numbers within one description are no longer possible.

Unfortunately, we are not able to accept shipping instructions which are not in line with the above requirements.

On page 3 and 4 of this CustomerInfo you will find examples to illustrate these requirements.
