Damage repair cost threshold limit for Dry / HAZ / Reefer units will be upto (INR 8500 + GST) .Repair cost incurred above this threshold limit, would be payable on the full repair amount.

Threshold Limit for Special Cargo and types of Material to be considered under Special Cargo **

All Metals Scrap such as Iron/Steel, Aluminium, Metal pipes & Any other metal Scrap material.

Damage repair cost threshold limit for special cargo will be upto (INR 20000 + GST) . Repair cost incurred above this threshold would be payable on the full repair amount.
