

Customer Roll Fee for U.S. Exports

Administration fee for containers rolled over to another sailing after gating in full at Inland or Marine terminal due to customer request, cargo inspections, missing or incorrect mandatory customs documentation, held by customs authorities at destination prior to the loading at origin port or similar events outside carrier's control. The charge amount includes per roll charge assessed by the terminal operator.

Per Diem export storage and / or export demurrage is not part of the CRO fee and may be assessed separately based upon excess dwell at the terminal.
