Hapag-Lloyd offers to customers discounted additional Free Days for Detention at destination (ADFT) according to the Hapag -Lloyd ADFT tariff, which can be accessed online at <https://www.hapag-loyd.com/en/landingpage/additional-freetime.html>

The following terms apply:

The scope of ADFT is currently limited to additional detention freetime at destination and to 20GP and 40GP/HC hazardous and non-hazardous . Shipments of special equipment and Reefers are not eligible for Freetime Day-Packages.

ADFT can be purchased in Freetime Day-Packages for a discounted price against the tariff rate . The maximum amount of purchasable additional free time is 10 days per Freetime Day-Package and Shipment. The purchased additional freetime days will count on top of the free days already agreed and applicable for the individual shipment.

The purchased Freetime Day-Packages have to be paid in full within fourteen days or latest before vessel arrival at port of destination, whichever comes first. If a customer has agreed credit terms in a service contract, these terms shall govern payment.

Unused freetime days cannot be refunded .If the Merchant exceeds the purchased additional freetime days, the standard terms and conditions for detention and demurrage of the Hapag-Lloyd tariff will apply. Additional Free Days only apply for the Carriers time pending detention charges at destination. Freetime Day-Package have no other effect on the tariff rules applicable for the shipment. Terminal storage, ramp storage cost, other time pending local charges etc. will continue to accrue.
