**SUB: GENERAL BOND FOR DESTUFFING AT CFS, AND FILING THE IMPORT
GENERAL MANIFEST UNDER SECTION 30 OF CUSTOMS ACT DIRECTLY WITH
INDIAN CUSTOMS FOR THE PERIOD FROM DD/MM/YY TO DD/MM/YY**

We would like to inform you that we have obtained the necessary authorization from Customs Authorities for filing the Consol Import General Manifest with the Indian Customs directly and our IGM consol agents registration number issued by the Nhava Sheva , Customs Authorities is **AACCA7791DCNNSA1**. We would now request you to kindly permit to file the Import General Manifest (IGM) with the Indian Customs .

In consideration of your allowing us to filing the IGM directly with the Indian Customs , we **M/s. ...**having office at Mumbai do hereby declare, guarantee and undertake as follows:

- 1) That we shall at our cost and risk de-stuff the cargo from the container and return the said containers in the sound condition.
- 2) We shall be responsible for filing of Import General Manifests (EDI and hard copy) directly with Indian Customs Authorities basis of our house bills of lading within the stipulated time once the IGM have been finalized by the Hapag Lloyd I Pvt. Ltd.
- 3) We shall keep the carrier and their agents completely indemnified and harmless from and against all the consequences, which may arise from your complying with our request including liabilities to a third party.
- 4) We shall be fully responsible for any amendments with the Customs and will be liable to attend the personal hearing with Customs directly and Hapag Lloyd I Pvt. Ltd will not be responsible for the same.
- 5) We shall hold you harmless and keep your absolved of all claims and customs penalties, which may be make upon you due to short/ excess landed cargo including cargo with wrong marking.
- 6) We undertake and guarantee that the responsibilities by spitting & sub-dividing the Master bill of lading line number will be done by us as per our House bill of lading. We also undertake to be fully responsible for all major or minor amendments with Customs without involving you either directly or indirectly. We undertake and guarantee that we will follow all Central, State Government while issuing Delivery Orders to our Customers under our House Bills of Lading.
- 7) We undertake & guarantee you that in case of any Show Cause Notices being issued by any Statutory Authorities concerning the consignments covered by the House Bill of Ladings manifested by us the same shall be dealt with by us right from the stage of initiation of proceedings till the culmination of such proceedings relating to our House bills of lading.
- 8) In case the containers are damaged in any manner whilst in our custody, we shall pay to you immediately, on your demand, the repair costs as estimated by your surveyors.
- 9) We undertake to remove the containers pertaining to our shipments to the nominated site or Cfs premises for destuffing & delivering cargo to the consignees under due custom super vision at our cost & expenses. We further undertake to return empty container at the storage yard nominated by you within 5 free days i.e. free period of 5 days from the date of landing of the loaded container. In the event of any delay for any reason whatsoever in returning the empty container to your nominated storage yard beyond the free days, we hereby undertake and container detention charges for the extra days as per your trariff.
- 10) This bond will remain in force till such time we comply with our above undertaking and fulfill all your/other authorities' requirements.
