<ul style="list-style-type: none"> <li>■ <b>Transmissions at least 24 hours prior to vessels loading operations</b></li> </ul>
<ul style="list-style-type: none"> <li>■ Transmissions have to be done for:                             <ul style="list-style-type: none"> <li>→ direct cargo</li> <li>→ transit cargo</li> <li>→ transshipment cargo</li> <li>→ Supplementary Reports (House Bills) are optional for FROB (Foreign Cargo Remaining on Board)</li> </ul> </li> </ul>
<ul style="list-style-type: none"> <li>■ Self-filer scenario allowed                             <ul style="list-style-type: none"> <li>→ forwarders can apply for self-filing</li> </ul> </li> <li>■ If a forwarder does not apply for self-filing, he has to ask his carrier to transmit the House Bill(s)</li> <li>■ Self-filer has to include in the House Bill transmission the Cargo Control Number/CCN. Different types of CCN exist, Hapag-Lloyd has chosen the shorted one: BI = Carrier Code &amp; OB = B/L without prefix</li> <li>■ Our Carrier Code is: 9529</li> </ul>
<ul style="list-style-type: none"> <li>■ Manifest needs:                             <ul style="list-style-type: none"> <li>Complete Shipper, Consignee and Notify address.</li> <li>Non-standard letters or symbols like for example 'ö', 'ä', 'ö', are not accepted.</li> </ul> </li> </ul>
<ul style="list-style-type: none"> <li>■ PALLETS not accepted</li> </ul>
<ul style="list-style-type: none"> <li>■ Complete and precise cargo description required - "FAK" or general cargo descriptions are not accepted</li> </ul>
<ul style="list-style-type: none"> <li>■ 'said to contain' not accepted</li> </ul>
<ul style="list-style-type: none"> <li>■ Seal number(s) required</li> </ul>
<ul style="list-style-type: none"> <li>■ Gross weight of cargo merchandise</li> </ul>
<ul style="list-style-type: none"> <li>■ Piece count and unit of measure</li> </ul>
<ul style="list-style-type: none"> <li>■ Number, quantity and type/size of container</li> </ul>
<ul style="list-style-type: none"> <li>■ Language: English (French accepted additionally)</li> </ul>
<ul style="list-style-type: none"> <li>■ In case of dangerous goods – required as per IMO regulations</li> </ul>
