DOCUMENTATION REQUIREMENTS

B/L Type : SWB or OB/L (Combined BL for Break Bulk cargo & Containerized cargo is not allowed in UAE.)

Shipper Details : Name, address, contact details, PO Box

Consignee Details : Name, address, PO Box ctc numbers/person. Must be in UAE (Email address & phone number should exist)

Notify Details : Name, address, PO Box ctc numbers/person. Must be in UAE (Email address & phone number should exist)

Freight Details : If charges are to be shown, break-up preferable.

Payment terms : Freight collect is only possible if prior approval has been obtained from the destination office.

Part Load Bs/L : Part Bs/l acceptable. But consignee on both must be same. Payment details can be shown on one B/L with second B/L bearing its reference

Print B/L at Destination : Acceptable

Transit cargo : Not accepted on carrier's responsibility. For cargo in transit on consignee's risk & expenses, carrier's responsibility ceases at discharge port.

RESTRICTIONS

Please be informed that Export/ Import/ Transit of Waste material as per Basel convention including electronic waste, waste batteries etc., within Dubai Ports without approval from the Competent Authorities of UAE is strictly prohibited.

Environment and Water, Customs etc.,) prior to the export/ import and transit of banned waste material and Advance notification must be submitted to all relevant authorities.

If any cargo/container is found to contain such banned waste material irrespective of quantity within Dubai ports without necessary approval will be handed over to law enforcing agencies and will lead to appropriate sanction against the person or companies involved in such export/ import or transit in accordance with EHS-Trakhees, Local and Federal law.

UNITED STATES OF AMERICA (USA):

DOCUMENTATION REQUIREMENTS

B/L Type : SWB or OB/L

Shipper Details : True shipper required (Full addresses is requested, but will accept P.O. Box)

Consignee Details : True consignee required (Full addresses is requested, but will accept P.O. Box)

Notify Details : If straight BL, notify is optional. If order BL, notify should be actual consignee. (Full addresses is requested, but will accept P.O. Box)

Packaging : Pallets are not sufficient.

Cargo Description : Vague descriptions are not acceptable.

Harmonized Codes : 6 digit HS Code required.

Freight Details : optional to incl charges

Payment terms : **For Personal Effects** charges cannot be invoiced to direct private parties. No other restrictions on collect charges. Elsewhere payment acceptable,LOI not required

Part Load Bs/L : FCL partload BLs are acceptable but must have a common Consignee or Notify Party 1. Freight can be split if required. Part Load Bs/L are not allowed for Personal Effects or Household Goods.

RESTRICTIONS

Hapag-Lloyd USA will only accept shipments of personal effects (household goods) when certain criteria are met:

- Direct private shippers are not accepted (Must be represented and be listed on the BL on Export and Import side by Broker/Freight Forwarder)
- Owner of the effects must be named on the bill of lading
- Door Moves at a customer's personal residence are not permitted

- HHG Shipper associations / NVOCC's etc are not affected by these limitations

Most do-it-yourself shippers of personal effects are not at all familiar with the relevant rules and regulations, and don't know how to submit the respective data to Customs. They are also not informed about the additional charges occurring in the port of loading/discharge related to shipments of personal effects (e.g. clearance, demurrage, detention, stripping, reception etc...), resulting in difficulties for Hapag-Lloyd to collect these amounts.

It is therefore it is required that PE Shipper hire competent Forwarder/Broker to assist with these important items.

Please provide PE shippers with this helpful guide when possible.

USA: Personal Effects Tip Sheet

It is important to use for household goods/personal effect shipments for USA* cargo (*for USA direct, transit, transshipment and FROB (Foreign cargo Remaining On Board) cargo) the HS Code must be 98 04 00, in order to avoid problems with the U.S. import customs clearance.

NO HHG Shipments via Cross-Border: Personal Effects are banned for movement by Rail and/or truck from POD Canada/U.S to U.S./Canada. Any shipment booked as such will be terminated at the applicable POD and/or returned to origin.

USA - Restricted commodity Gaming / slot machines or gambling device imports

Due to customer difficulties to consistently adhere to strict local regulations, we cannot accept the commodity "gaming / slot machines / gambling tables or any other type of machines / similar devices which are designed / manufactured and used for gambling" as imports into the USA. This commodity is restricted with immediate effect

USA: Transporting Motor Vehicles on the Rail Network

Clarifying the ban put in place November 2007, effective immediately and until further notice, **ALL** shipments of motor vehicles originating from or destined to any United States inland point will not be offered.

This service suspension **does not** include shipments of household goods or personal effects containing motor vehicles. Please see the approved shippers list prior to accepting hhg / personal effects shipments containing automobiles.

Motor vehicles can include such items as golf carts, motor cycles, farm machinery, and road working machinery.

North America: Approved Personal Effects / Personal Automobile Shippers

North American rail roads restrict certain commodities moving via the rail network. Household goods moving with personally owned motor vehicles are restricted commodities. Straight shipments of personally owned or used motor vehicles are banned. Currently Hapag Lloyd only requires a signed customer indemnification letter (LOI) for HHG containing personally owned motor vehicles occurring within the United States. HL only allows the movement of 1 personally owned vehicle per TEU with HHG. The LOI must be signed by an officer of the contract holding company.

Note -- Only transports of personal effects / household goods containing personally owned motor vehicles are accepted for transport. Otherwise, Hapag Lloyd does not allow transports of used motor vehicles on the American rail networks except NS rail. The following customer's indemnification agreements are valid for 1 year - either from date of receipt or contract expiry whichever comes first.
Please do not accept HHG shipments containing personally owned motor vehicles for any shipper unless specifically noted in the table below.

North America: Banned and Restricted Commodities by Rail Roads

Banned / Prohibited Commodities:

Banned / prohibited / forbidden commodities are never accepted for transportation by NS and its railroad subsidiaries, and may not be loaded by a shipper or under instruction of a rail services buyer in trailers or containers for movement via NS.

Restricted Commodities:

Restricted Commodities are accepted for shipment when all shipping requirements as outlined below have been met. Items listed on the NSRR Rules circular and mis-declared or mis-described on the shipping instructions are subject to a \$1,000 per container fine.

US – Ship Spares Handling Process

This request must include a detailed “discharge packing list including pro forma invoice value.” Request must be received at least 72 hours prior arriving a.m. US ports (better earlier), but also now needing an ISF10 (security filing). The US POD may need to obtain a customs broker to file ISF10.

- Booking Team to have shipment created and rates finalized.
- Documentation to create the Bill of Lading.

Rejected Import Cross Border Shipment USA/Canada

For cross border shipments involving NCA and NNE the responsibility of the area handling the re-export will be based on location of the cargo as well as party responsible for the move. For example, if container discharged in Canada and moving on the rail to Chicago and was held by Customs at the border in Canada, NCA will be responsible for handling the return shipment. NNE's responsibility to handle re-export will begin when container reaches the destination. In a similar manner when a container discharges in New York and is moving to Toronto and was held at the border the NNE team will handle the request to re-export. If a customer insists on booking with another booking office for the export shipment due to an established relationship.

Instructions to return the shipment by Customs are often of an urgent nature and must be handled expeditiously. This process is intended to clarify any possible misunderstanding and facilitate the quick set up of the return shipment through streamlined communication with all involved parties.

USA: Top 10 Banned and Restricted Commodities on the Rail Network

Automobiles or motor vehicles, whether new or used. Includes motorcycles, fork lifts, road working machinery:

Banned unless moving with Personal Effects or via the Norfolk Southern Railroad in direct lanes only. To transport used motor vehicles, Sales must either include tariff language LOI in the customer's service contract or procure an LOI prior to HL accepting for transport. It is the responsibility of Sales to communicate this detail to operation in a timely manner.

To transport HHG with personally owned motor vehicles the contract holder must sign a Letter of Indemnity and submit to QSCRail@hlag.com

Cigarettes and Tobacco:

Restricted on all North American Railroads. Requires the BCO to protect the shipment with a waterproof liner no less than 5 mm thick.

Concentrated Metal Products including but not limited to all metal products that are coiled, rolled, reeled, spooled, sheets, or rods:

Restricted. If the gross weight per package exceeds 3,500 lbs the contract holder is required to sign a Letter of Indemnity and follow proper guidelines to transport. If interested in transporting this commodity contact QSCRail@hlag.com for details. If the gross weight per package exceeds 12,000 lbs HL cannot accept this item for transport.

Flexi Tanks and Bulk Bladder Bags:

Restricted on the UPRR, CSX and Norfolk Southern. Requires clearance of Germany to transport. If transporting on the USA Western Network may require an additional Letter of Indemnity prior to transport.

Hides and Skins:

Restricted. Requires liner bag to prevent leaking of contents. It is the sole responsible of the shipper to ensure the cargo can transport without contaminating Hapag Lloyd or Railroad equipment. Prohibited between Kansas City and New York.

Household goods, personal effects, removal goods:

Restricted. Requires no LOI unless transporting with personally owned motor vehicles. Banned cross border US/Canada.

Machinery, used:

Restricted. The railroads require Hapag Lloyd to indemnify them to transport this commodity. HL requires an LOI from the customer to transport and rail vendor pre-approval.

Medical equipment and supplies including but not limited to gowns, syringes, x-ray machines, MRI machines, prescription and non-prescription medication:

Restricted. Requires the contract holder to sign a Letter of Indemnity to transport on the Western Rail network.

Scrap metal. Excludes scrap/used auto and machinery parts:

Restricted on all North American Railroads.

Used Tires.

Restricted on all North American Railroads.

QATAR:

B/L Type : SWB or OB/L

Shipper Details : Name, address, contact details, PO Box (Full Style address is required. If possible email ID of the shipper is preferred.)

Consignee Details : Name, address, PO Box is mandatory. Full contact numbers / person in charge etc. Must be a company in Qatar. (Full Style address is required. E-mail ID of customer preferred.
Email address & phone number should exist.)

Notify Details : Name, address, PO Box contact numbers/person. (Full Style address is required. E-mail ID of customer preferred. Email address & phone number should exist.)

Harmonized Codes : Preferable but not mandatory presently

Freight Details : If charges are to be shown, break-up preferable.

Payment terms : Collect charges are acceptable with clear details. Freight collect is only possible if prior approval has been obtained from the destination office.

Part Load Bs/L : Part Bs/l acceptable. But consignee on both must be same. Payment details can be shown on one B/L with second B/L bearing its reference

Print B/L at Destination : Not accepted.

RESTRICTIONS

Qatar (Restrictions and Basic Guidelines for cargo)

The import of all kinds of scrap materials is restricted in Qatar. For any import (from any country), prior approval has to be obtained from the Port, Customs and relevant authorities in Qatar. NO shipment should be loaded for Doha without prior approval else cargo will be returned back to origin and all costs related to same would have to be borne by the shipper.

***Qatar, Doha:** pork and all items containing pork and ham are totally prohibited for imports (the only exception allowed is for the US Military for import into their base for their own consumption).

Doha, Qatar – Sensitive Cargoes in Operating Reefers during Summer

The Doha Port Authority / Supreme Council of health in Qatar has issued a circular indicating that certain commodities/cargoes (see below) are required to be loaded on operating reefers due to the onset of high temperatures this summer season.

Shippers and customers are requested to load the following in live reefers to avoid any claims/cargo damages etc. for all imports/exports to/from Qatar during this period – from May to October.

- Juices, soft drinks, drinks of all kinds and forms except concentrated ones.
- Chocolates of all kinds and forms.
- Stuffed biscuits (wafers) in all its forms.
- Children liquid foods and mashed in all kinds and forms.
- Pastries and baked goods of all kinds.

SAUDI ARABIA

B/L Type : SWB or OB/L

Shipper Details : FULL ADDRESS, TEL & email address are mandatory, Fax number is optional. PO BOX is acceptable as an additional information only.

Consignee Details : With phone and email address. Foreign cnee name is not acceptable. Cnee name must be within Saudi Arabia. In case of switch bl actual cnee details must be updated at least 3 days prior vessel Eta at POD. Failing which leads to huge penalty from customs and ROB of contrs. (Company Name, TEL & Email address are mandatory - PO BOX is acceptable as an additional information only. Email address & phone number should exist.)

Notify Details : Company Name, TEL NOS, Email address are mandatory - PO BOX is acceptable as an additional information only.

Packaging : Inner packing also required if it DG otherwise packing is sufficient and pallets are acceptable .

Freight Details : No frt details required for customs manifest.

THO & THD to be included into sea freight.

Payment terms : Freight collect is only possible if prior approval has been obtained from the destination. All refrigerated shipments must be prepaid for Saudi destinations. (Please note that DDF, PDO & RHD are local charges and payment term must be always 'Collect'. In case of Place of Delivery Riyadh; when freight is prepaid, DLF & HDL must be prepaid. DLF and HDL alone not possible to collect at destination. GFD (Gate Fee at Destination) is applicable for all units being discharged at Saudi Arabia as Imports.)

RESTRICTIONS

Saudi Arabia: Restrictions and Basic Guidelines for cargo

Basic guidelines

All containers discharged in Jeddah bound for Saudi Arabia are cleared by consignee broker inside the Jeddah port without exception. All containers are entirely devanned for customs inspection and revanned again for release to consignee, regardless of cy or house delivery terms. In order to speed up devanning/revanning operations, the Saudi Port Authority has implemented the pallet rules. Violations are subject to hefty fines (minimum Saudi Rial 1000 per container, which is levied against the consignee. Pallet rules: no pallet or unit may exceed 2000 kg (4400 lbs.)

Timber and plywood: Jeddah Islamic Port has no objection if timber and plywood sheets are shipped inside the containers. Such cargo shall be stacked properly on pallets to facilitate the process of handling this cargo by the forklift and sufficient space must be provided between the rows so that the process of handling with the fork lift is not impeded.

Waste/Scrap Plastic: Import is restricted.

Building materials: must be palletized or unitized. Building materials, including sanitaryware and tiles, may continue to be shipped in closed dry containers, provided that they are palletized or unitized to allow handling by forklift truck. Building materials are classified as any type of material used in the construction of, or employed as fixtures or installations, in buildings of any sort.

Bagged cargo and drums: must be palletized or unitized.

Heavy machinery and equipment: must be unitized or palletized. Heavy machinery and equipment exceeding the unit weight limit of 2000 kg may be shipped in open top containers, flats, platforms or open trailers.

Cars (automobiles, trucks): can now ship in standard equipment but must be unlocked and accompanied by keys to allow them to be driven for examination. This applies to all Saudi ports.

Steel structures banned completely: steel structures are banned completely from shipment in closed dry containers. Steel structures may be shipped in open top containers,

flats, platforms or open trailers. They must be unitized, preslung or fitted with lifting points to permit immediate access by mechanical means.

Cargo not mentioned specifically in the categories above are not affected by the Saudi Port Authority's restrictions on the shipment of cargo in closed dry containers.

Packing lists: in order to avoid damage during devanning/revanning operations, the port has implemented the packing list rules, i.e., packing list has to be placed inside container door, also with consignees name, address/fax/telephone/telex numbers. Violations are subject to a fine of Saudi Rial 500. Which is levied also against the consignee.

Reefer containers: Reefers destined to Persian Gulf and Red Sea ports may be accepted. All reefers destined to Middle East ports must be on prepaid basis. Reefers on "Door Delivery" basis in Saudi Arabia are not accepted.

Import of liquor totally prohibited for Saudi Arabia and NOT allowed even for transshipment via any Saudi ports. Jordan, Oman, Bahrain and United Arab Emirates are not subject to these restrictions, unless cargo is transhipped in Saudi Arabia.

Dangerous cargo: Jeddah Islamic Port (JIP) Safety Department is observing MOI rules very strictly without exception, and any violation will be fined with a minimum of Saudi Rial 5,000. IMO cargo has to be mentioned on the mandatory packing lists inside the container doors and respective labels must be placed on parcels / units. Hazardous cargo can be accepted for transshipment via Jeddah for Aqaba, Hodeidah, Aden, Port Sudan subject to approval by the feeder operator prior to accepting the hazardous cargo at port of origin. All details must be provided to HL Jeddah office to take approval from the feeder operator. Only for Jeddah and KAP, all commodities of chemicals must have pre-approval sought prior accepting bookings at POL and must be shared with Jeddah for verification. Pre-approval from customs and shipping agent has to be submitted to stevedoring company along with manifest 3 days prior vessel arrival.

Container weight: maximum weight permitted for discharge is as per CSC plate and must not exceed 60 metric tons gross (SWL of the gantry cranes).

Road limitations: road limitation in Saudi Arabia is 25.0 metric gross tons. Do not accept door delivery for containers exceeding this weight. It is possible to transport containers with higher weight, but requires special permission and case need special lowbed trailers, which difficult to hire in Saudi Arabia.

Transshipment cargo via Jeddah: It is not acceptable dangerous cargo, or other cargo prohibited for Jeddah discharge in general. Cargo which would fall under MIO (Ministry of Interior) regulations in Saudi Arabia is not allowed in t/s as well.

Bill of Lading / Manifest: It is mandatory to have the local customer/s name, address and contact numbers defined in the B/L either in consignee or notify party. Contravention to the Port Rules and Regulations will be subject to heavy penalty

Cars (automobiles, trucks): Passenger cars, buses and light loaded-trucks imported to the KSA must not exceed 5 years of age and heavy trucks must not exceed 10 years of age. As for the antique cars of 30 years old and more of made date, it is allowed to be imported under the following condition:

- Load port should write down on the customs card this statement "Antique for possessing".

Animal and Plant Cargos pre-approval: Pre-approval is mandatory document to be obtained by consignee to import plant and animal cargos prior cargo shipped from port of load. Unless pre-approval document is obtained by consignee, port authorities will not allow cargo to be discharged and it will be returned on board.

Use of Pallets to Load Goods: Saudi Ports Authority mandates use of pallets to load goods in containers Exclusions from the mandate include dry or liquid bulk materials that are loaded directly on their means of transport, such as wheat, grains, cement, gypsum, and petroleum materials, as well as raw materials stored in jumbo bags of large weights precluding their placement on pallets, heavy machinery, production equipment, and generators. Also excluded are steel products in the form of large rolls, coils, or flats; iron rods, large pipes, scaffolding and the like; materials that are difficult to load on pallets such as insulators, cardboard, and carpets; furnishings in general; external aerated tires; and marble, stone, and granite.

Saudi Arabia: Dangerous Shipment Requirements

Riyadh Dry Port:

January 2021 - All DG cargo has been stopped with immediate effect. We are not carrying DG cargo to Riyadh until further notice.

Jeddah & King Abdullah Port

- All DG Shipments into Jeddah port, requires advanced Saudi Customs approval “DG permit” and final customs declaration “Final BAYAN” to discharge the DG unit.
- Consignee should obtain approval from Customs and submit to their Shipper prior loading

In case Saudi Customs approval “DG Permit” or final customs declaration “Final BAYAN” are not available, Terminal will not discharge the container and it will be consider as ROB status.

- Such permissions can't be arranged by HL on behalf of Consignee.
- All DG cargo with DG class 5.2 must be loaded only in reefer units.

Dammam & Jubail Port

Specific DG cargo into Dammam & Jubail requires “ MOI Permit “ to discharge the containers.

- Consignee should obtain approval from Customs and submit to their Shipper prior loading.
- All DG cargo with DG class 5.2 must be loaded only in reefer units.
- Such permissions can't be arranged by HL on behalf of Consignee.
- In case “ MOI Permit” not available, Terminal will not discharge the container and it will be consider as ROB status.

Notify Details : Name, address, PO Box ctc numbers/person. Must be in JORDAN.
e-mail address compulsory, Fax number is optional

Packaging : Preferable to have inner packings with total number of packages, country of origin label etc.

Harmonized Codes : HS CODE ARE REQUIRED

Freight Details : If charges are to be shown, break-up preferable

Payment terms : Collect charges are acceptable with clear details

Part Load Bs/L : Any cargo stuffed as Part load BLs (FCL Container with more than one B/L) is not accepted.

Print B/L at Destination : Not accepted.

Transit cargo : Acceptable on consignee's risk & account, carrier's responsibility ceases at discharging port.(provided that IN TRANSIT TO B ON C/NEE RISK & ACCOUNT should be inserted on both the manifest + b/l)

RESTRICTIONS

Jordan: Restrictions and Basic Guidelines for cargo

Cigarettes, Tobacco and Hay – Due to abandonment issues and the hardship of re-exportation of these commodities, it is required that at the time of booking the shipper provide the full details of the consignee; Name, Address, Phone and email. The Jordan office will return approval or denial within 24 working hours to the booking desk; approval to continue with the booking or denial to cancel the booking request.

Scrap – All scrap and waste cargos are prohibited.

Vehicles (Cars) - Not less than 5 years old.

THE UNITED KINGDOM:

Activated Carbon is a form of carbon high surface area. It is mainly used for filters, medicine, sewage treatment, respirators.

It might be classified as IMDG Class 4.2, UN 1361 or 1362 and must be packed according to the provisions of the IMDG Code. All Bookings (DG or NON-DG) must be verified by the Regional DG department.

NON-DG bookings to be marked with Special Product "CARB".

Charcoal Non-DG

Charcoal is a substance obtained by partial burning or carbonization (destructive distillation) of organic material.

Flexitanks

A flexitank is a strong plastic bag for liquids, filling the almost whole container. It is only for non-DG cargoes and a cost effective alternative to tank containers, drums or ibc. Only whitelisted flexitanks or commodities are accepted.

Hides - Wet, Blue, (Dry)

WET and BLUE HIDES are compulsory to register as Special Commodity: WETHIDES. This flags automatically the Special Product "WETS".

DRY HIDES are not needed to be marked.

Hides might have a terrible smell and if leaking they contaminate the container floor and other cargoes.

The type or classification of hides (wet, blue, dry), depends on the degree of fabrication.

Metal Scrap

Metal scrap size and structure varies. Best practice is to pack it in cases, on pallets, in big bags or pressed in bales/bundles.

If it shall be stuffed loose, specific rules have to be followed to protect the container. Only customers that signed the LOI are allowed to load scrap in bulk.

Additional cost for the separation of boxes for scrap at the depot shall be charged to the customer.

Sensitive Commodities

Based on our Global Code of Ethics and our Sustainability Policy, to protect our environment and maintain our good reputation, Hapag-Lloyd has decided to NOT transport the following sensitive cargoes/commodities.

Fishmeal (IMO regulated or not) may be stuffed as bulk in HLAG owned containers, provided special requirements are fulfilled.

Granite & Marble Blocks

Granite & Marble Blocks have a high weight on a small resting area.

Therefore,

- exceeding weight stresses and damages the steel beams of the container floor

Lithium Batteries and Lithium Ion Batteries, Non-DG

Lithium Batteries and Lithium Ion Batteries are electrical batteries containing lithium or lithium ion encased in a rigid metallic body. Lithium Batteries or Lithium Metal Batteries are primary batteries that have metallic lithium as an anode. A Lithium Ion Battery is a type of rechargeable battery. They are commonly used for portable electronics and electric vehicles. Both types may also be shipped with equipment or packed in equipment.

As long as on board date is on/after Oct 4th 2018 the more restricted rule is applied.

1. Plastic scraps are the defective products after manufacturing process.
2. Plastic scrap is made from single material or is single form.
3. Importers in Taiwan need to be factories that are registered with Taiwan Government Authority.
4. For any violation cargos must be returned back to origin and authority will impose penalty
