Date aggiornate di accettazione per l' Intermodale Export e Import:

- **Accettazione Intermodale export da Padova / Modena / Milano tranne Melzo fino a venerdì 25/07**
- Accettazione IMPORT Fast Corridor Melzo fino a mercoledì 16/07
- Dal lunedì 21/07 tutti i viaggi export potranno essere gestiti esclusivamente in modalità r/trip (come precedentemente annunciato), mentre i viaggi import continueranno a essere in one way, come da tariffa pubblica, ma saranno soggetti ad una **peak season surcharge già notificata.**
- Per Export: Si consiglia di imbarcare il piu possibile da ITSPE e ITLIV (Terminal Darsena Toscana)
- Import sbarco Genova Intermodale, NON Fast Corridor, Ultima data di accettazione, sbarco 18 Luglio 2025.

Verrà introdotta come già anticipato nella Customer Letter del 05/06/2025, a fare data dal 16/06/2025 una Rail Disruption Surcharge (RDSUR) di Euro 25, per ogni TEU trasportato via ferrovia. Per gli shipment regolamentati da FMC a partire dal 06/07/2025

Questa misura si rende necessaria per far fronte ai significativi costi operativi aggiuntivi derivanti da:

- L'utilizzo di tracce ferroviarie alternative con conseguente allungamento dei transit time;
In particolar modo:

Dal 9 giugno al 28 settembre per la manutenzione straordinaria di Ponte Po (zona Pavia) che potrà determinare posticipi e deviazioni su itinerari alternativi dei treni sulla tratta di Milano / Genova (che sarà via Piacenza) e Spezia / Milano (che sarà fatto via Prato / Bologna / Modena). Questi interventi causeranno un allungamento dei percorsi con maggiore impiego di risorse e conseguente possibile modifiche della programmazione ordinaria.

Altri interventi sono previsti su numerose tratte ferroviarie nel mese di agosto (aree di Vicenza , Milano , Verona e Bologna) che, pur non causando interruzioni continuative di tratte o servizi, potrebbero alterare la normale circolazione ferroviaria con un incremento del rischio di ritardi e soppressioni.

- L'impiego straordinario di risorse (carri, locomotori e personale) per garantire la continuità del servizio.
- Le interruzioni totali previste nel mese di agosto sulle tratte da/per Genova, che comporteranno la sospensione temporanea dei servizi ferroviari e intermodali su tali relazioni nei periodi indicati.

La surcharge sarà applicata a tutte le unità (import ed export) via ferrovia, da e per tutti i porti, indipendentemente che siano direttamente coinvolte nei lavori infrastrutturali come già anticipato nella customer letter del 05/06/2025.

Desideriamo informare che, a partire dal 14 luglio 2025 e fino al 31 agosto 2025, le unità in import sbarcate nei porti di Genova (ITGOA), La Spezia (ITSPE), Livorno (ITLIV) e Vado Ligure (ITVDL) potranno subire ritardi nelle consegne causa della generale carenza di capacità camionistica. Poiché tale situazione è dovuta a cause al di fuori del controllo della Linea, non sarà possibile concedere esoneri ("waiver") sui costi derivanti dalle soste.

Due to major disruptions and planned diversions on the Italian railway network during the summer of 2025—particularly in August, with the complete closure of the Genova Voltri and Genova Marittima hubs from August 2 to August 31, 2025

Deadline for final acceptance of Intermodal Export and Import:

- **Export Intermodal acceptance from Padova / Modena / Milano (excluding Melzo) until Friday, July 25th**
- IMPORT Fast Corridor Melzo acceptance until Wednesday, July 16
- Starting Monday, July 21, all export shipments will be managed exclusively in round trip mode (as previously announced), **while import shipments will continue to be handled one way, according to public tariffs, but will be subject to a peak season surcharge, already notified.**
- For Export: We recommend shipping as much as possible from ITSPE and ITLIV (Terminal Darsena Toscana).
- Import via Genova Intermodal (non-Fast Corridor): Last acceptance date for discharge is July 18, 2025.

As previously announced in the Customer Letter dated June 5, 2025, a Rail Disruption Surcharge (RDSUR) of €25 per TEU transported by rail will be introduced starting June 16, 2025. For FMC-regulated shipments, this will apply from July 6, 2025.

This measure is necessary to cover the significant additional operational costs resulting from:

- The use of alternative rail routes, leading to extended transit times. In particular:

From June 9 to September 28, extraordinary maintenance on the Ponte Po (Pavia area) may cause delays and diversions on the Milano/Genova route (via Piacenza) and Spezia/Milano route (via Prato/Bologna/Modena).

These interventions will lengthen routes, require more resources, and may lead to changes in regular scheduling. Additional works are planned on several railway lines in August (Vicenza, Milano, Verona, and Bologna areas), which, while not causing continuous service interruptions, may disrupt normal rail traffic and increase the risk of delays and cancellations.

- Extraordinary use of resources (wagons, locomotives, and personnel) to ensure service continuity.
- Total closures expected in August on routes to/from Genova, resulting in the temporary suspension of rail and intermodal services on those routes during the specified periods.

The surcharge will apply to all units (import and export) transported by rail to and from all ports, regardless of whether they are directly affected by the infrastructure works, as previously stated in the Customer Letter of June 5, 2025.

We would also like to inform you that, from July 14 to August 31, 2025, import units discharged at the ports of Genova (ITGOA), La Spezia (ITSPE), Livorno (ITLIV), and Vado Ligure (ITVDL) may experience delivery delays due to a general shortage of trucking capacity. As this situation is beyond the Line's control, no waivers on detention or demurrage costs will be granted.
