Dear Customer,

To ensure a smooth and efficient shipping process for your cargo, we are writing to provide a friendly reminder regarding the booking declaration and document submission requirements for special cargo contains **lithium batteries, activated carbon, Flexitank, plastic pellets/nurdles and etc.**

Due to the special physical/chemical properties of such cargo, our company has clear loading requirements to ensure safe and compliant transportation — priority will be given to on-deck stowage. This operation requires the completion of cargo attribute verification and loading application procedures in advance.

Plastic pellets/nurdles shall be arranged for under deck stowage due to the cargo properties.

To better support your shipping arrangements, we kindly request that you accurately declare the full name and complete attributes of the cargo when making bookings. If additional verification documents (such as MSDS documents, non-dangerous goods identification reports, etc.) need to be submitted subsequently, please do so through our **online amendment channel (declare your commodity name in remark column)** for efficient review and to ensure a seamless process.

Effective December 1, 2025, for the purpose of unified management and efficient review, all additional verification documents for special cargo must be submitted via the online channel.
