

# IMO CONTAINER MANAGEMENT POLICY

Dear customers, dear partners,

Please be advised of the adjustments made to the IMO container management policy, as detailed in the circular note from the CEO of PAD, dated 2 May 2025 (ref. No. 582/PAS/EM/P/CAB) regarding the declaration and handling of dangerous goods.

## With Immediate Effect

In line with the new measures, the cyanide containers (UN 1689) will be delivered under tackle and only under secure escort with the approval of the relevant authorities.

This change is intended to enhance security at the container terminal and improve the flow of operations.

# Reminder of the general conditions for managing IMO containers

#### 1. Transmission of Customer Details

The shipping line is required to send customer information to <a href="mailto:CustomerService.Dakar@dpworld.com">CustomerService.Dakar@dpworld.com</a>, 3 days before the ship's arrival:

- A copy of the bill of lading
- MSDS
- Customer and freight forwarder contact details

## 2. Delivery under tackle

Containers in the classes below must be moved promptly upon unloading from the vessel otherwise, the cargo will be refused (reloaded or remains on board):

- Class 1: Explosives
- Class 2.3: Toxic gases
- Class 4: Flammable solids and other explosive solids
- Class 5.1 (UN 1942): Ammonium nitrate
- Class 6.1 (UN 1689): Sodium cyanide

NB: This condition is applicable in accordance with the UN number corresponding to the class of the goods in question. For more details, please refer to the management policy attached to this letter.

## 3. Conditions for the removal of other IMO categories (2.1-2.2-3-8) and 9)

These categories of containers must be removed within a maximum of 3 days after unloading.

After this period, the shipping line will be responsible for transferring them out of the Terminal or re-exporting them and will bear all related costs.

To ensure compliance and collective safety, it is essential to adhere strictly to all the measures outlined here. We thank you for your understanding and cooperation.
